OUTREACH SERVICES - IN 2019, WE SERVED 48,334 MEALS TO HUNGRY MEN, WOMEN AND CHILDREN. WE ALSO HAD 1588 PEOPLE WHO CAME TO OUR WALK-IN HOURS FOR ASSISTANCE MEETING THEIR BASIC NEEDS, INCLUDING 1059 PEOPLE WHO RECEIVED CLOTHING, 904 PEOPLE WHO RECEIVED HYGIENE SUPPLIES, 115 PEOPLE WHO RECEIVED TRANSPORTATION ASSISTANCE, 34 PEOPLE WHO OBTAINED BIRTH CERTIFICATES AND/OR IDS, 178 PEOPLE WHO WERE ASSESSED AND ADDED TO THE COMMUNITY'S WAITING LIST FOR HOUSING ASSISTANCE, AND 181 PEOPLE WHO WERE CONNECTED WITH OUR OTHER PROGRAMS. THROUGH OUR HOMELESS INTERVENTION PROGRAM, WE MOVED 66 HOMELESS HOUSEHOLDS, INCLUDING 81 ADULTS AND 34 CHILDREN, INTO PERMANENT HOUSING. FURTHERMORE, 90 PEOPLE ATTENDED CHAPEL SERVICES AND 181 PEOPLE ATTENDED STEADY HANDS, OUR WEEKLY DISCIPLESHIP GROUP.

RESTORATIVE SERVICES - MEN WHO WERE TRYING TO GET BACK ON THEIR FEET AFTER HOMELESSNESS, SUBSTANCE ABUSE, INCARCERATION, OR JUST FALLING ON HARD TIMES HAD WARM BEDS AND A SAFE PLACE TO CALL HOME IN OUR TRANSITIONAL LIVING PROGRAM. IN 2019, WE PROVIDED TRANSITIONAL HOUSING TO 120 MEN. WHEN RESIDENTS FIRST COME INTO THE PROGRAM, THEY MOVE INTO A DORMITORY-STYLE LIVING ENVIRONMENT AT THE POTTER'S HOUSE WHILE THEY SETTLE IN, STABILIZE, AND SECURE EMPLOYMENT. RESIDENTS ARE THEN MOVED INTO MORE PRIVATE ROOMS AT THE HOUSE OF HOPE AFTER THEY HAVE COMPLETED PHASE ONE. GOALS FOR OUR RESIDENTS INCLUDE SECURING EMPLOYMENT, MAINTAINING SOBRIETY, COMPLETING OUR JOB-READINESS COURSE, LEARNING TO LIVE WITHIN A BUDGET, MEETING WITH A CASE MANAGER ON A REGULAR BASIS, AND BUILDING A POSITIVE SOCIAL NETWORK, INCLUDING RECONNECTING WITH FAMILY.
