RESTORATIVE SERVICES - MEN AND WOMEN WHO WERE TRYING TO GET BACK ON THEIR FEET AFTER HOMELESSNESS, SUBSTANCE ABUSE, INCARCERATION, OR JUST FALLING ON HARD TIMES HAD WARM BEDS AND A SAFE PLACE TO CALL HOME IN OUR TRANSITIONAL LIVING PROGRAM. THE AVERAGE SALARY WAS \$12.08, AND THE AVERAGE NUMBER OF HOURS WORKED PER WEEK WAS 35-39. THE TOP SECTORS WE PLACED PEOPLE IN WERE SKILLED TRADES, MANUFACTURING, AND HOSPITALITY. WE ALSO TAUGHT 206 PEOPLE EMPLOYMENT SKILLS, AND 39 GRADUATED FROM JOBS FOR LIFE. IN 2021, WE ALSO LAUNCHED OUR LAWN CARE AND LANDSCAPING BUSINESS TO EMPLOY HARD-TO-PLACE CLIENTS, AND WE HAD 34 RESIDENTIAL CUSTOMERS AND FOUR COMMERCIAL CUSTOMERS FOR OUR NEW SOCIAL ENTERPRISE.
