RESTORATIVE SERVICES - MEN AND WOMEN WHO WERE TRYING TO GET BACK ON THEIR FEET AFTER HOMELESSNESS, SUBSTANCE ABUSE, INCARCERATION, OR JUST FALLING ON HARD TIMES HAD WARM BEDS AND A SAFE PLACE TO CALL HOME IN OUR TRANSITIONAL LIVING PROGRAM. IN 2022, WE PROVIDED TRANSITIONAL HOUSING AND DISCIPLESHIP TO 125 MEN AND 28 WOMEN.

WE TAUGHT 105 PEOPLE EMPLOYMENT SKILLS THROUGH JOBS FOR LIFE. IN 2022, WE ALSO MANAGED A LAWN CARE AND LANDSCAPING BUSINESS TO EMPLOY HARD-TO-PLACE CLIENTS.
